The Literary Committee at LREI is pleased to once again offer the Spring Book Fair. This fair offers you and your child(ren) a chance to purchase books on the summer required and recommended reading lists. The Fair will be held in the Bleecker Street auditorium on **ONE-DAY ONLY-Thursday, May 22, from 8am-6pm**. We encourage parents to shop with and for their children, but many Middle School students wander in and peruse the books during the school day without parents, and unfortunately without money to purchase books. Because this is a one-day-only sale, we will not allow children to put books on hold at any point during the day.

If you would like to allow your middle-school child to purchase books without you present, please fill out the attached pre-authorization form. You may either fax it to the school (fax # 212-677-9159, attention Tracie McGee), return it to the reception desk or the book fair sales table, or you may have your child bring it him/herself to the fair. We will keep these forms on file at the fair and allow your child (and only your child) to purchase books up to the maximum allowed on this form. We will only charge your credit card for books bought, not maximum allowed.
