Dear Soon-to-Be-Eighth Grade Families:

Before you know it, students will be packing and hitting the road for the annual eighth grade trip to Gettysburg, Pennsylvania and Washington, DC, which is scheduled for Tuesday, May 10, through Friday, May 13.

The attached form provides information about payment for the trip. **Please note that payment should be made directly to New Century Tours (NCT) who are handling the tour for us and NOT to LREI.** You can pay the full tour amount (\$668) in one payment or you can pay the deposit fee (\$100) and make installment payments for the remaining amount. Deposits are due to NCT by October 1, 2010, and full payment must be made by January 1, 2011.

Unless you indicate "No" on the payment form, you will automatically be enrolled in NCT's "Full Refund Guarantee Program," which is an additional cost of \$99.

We look forward to your child's participation in this important component of the middle school educational experience. Additional information about the trip will be forthcoming and we will schedule a parent meeting in the spring to discuss the trip.

Dear Parents and Students:

As part of the eighth grade core curriculum, the eighth graders will be making their annual trip to **Gettysburg, PA** and **Washington, DC** in May 2011. Your child will experience firsthand our nation's history through a careful study of memorials and monuments. The company LREI has chosen to plan this historical adventure is New Century Tours. The tour will be **four days** and **three nights** in duration. We will depart from the school on **Tuesday morning, May 10th** via deluxe motor coach bound for Gettysburg, PA. We'll spend a day and evening in Gettysburg and then travel to Washington, DC for the remainder of our trip. We will return home **Friday afternoon, May 13th**. Parents will be provided detailed information regarding the full itinerary and school trip policies and procedures in a final letter prior to departure.

A chaperone ratio of approximately one adult per ten participants will be maintained. This tour is school-sponsored and affiliated, and will be chaperoned by the core teachers along with other middle school faculty members.. In addition, New Century Tours staff will be on call 24 hours and provide nighttime security at the hotel from late evening to early morning. The cost of the tour is **\$668 per student (4 per room)**. This figure includes: round trip ground transportation, lodging, complete sightseeing each day, all meals, nighttime security, comprehensive insurance (accident and illness), and evening activities (a night tour and social-recreational activities).

The tour will provide a valuable insight into our nation's heritage for all participants. This letter should answer most of your questions regarding payment and NCT. GENERAL TERMS & CONDITIONS

New Century Tours, Inc. Insurance Resume: Accident, illness, and accident-related dental insurance coverage are provided for all participants. Limits per single occurrence are: \$5,000.00 for accident, \$1,500.00 for illness and \$750.00 for accident-related dental. Any charges not covered by insurance are the responsibility of the participant. Pre-existing conditions and air travel are not covered under this policy. Participating enterprises all maintain insurance coverage. New Century Tours, Inc. also maintains comprehensive general liability insurance. New Century Tours, Inc. is a proud member of the National Tour Association (NTA) and the Student & Youth Travel Association (SYTA).

Price Guarantee: The tour price quoted is fully guaranteed by New Century Tours, Inc. for all groups which meet the group size requirements detailed on the front of this letter. Groups NOT meeting the group size requirement are subject to an increase in the tour price. EXCEPTIONS to the tour price guarantee also include the unlikely event of an imposed increase in air, rail, or motorcoach fare due to circumstances beyond New Century Tours' direct control (fuel surcharges, departure taxes, etc.).

Supervision/Behavior while on Tour: Rules for behavior will be established by the chaperones and passed on to the students. Any violation of these rules could result in the student being sent home at the parent's expense and waiving any right for a refund. To make the trip as enjoyable and safe as possible, each participant is expected to exhibit responsible behavior at all times.

Standard Cancellation Policy: All cancellation/refund requests must be made in writing to New Century Tours, Inc., 147 Old Solomons Island Road, 4th Floor, Annapolis, MD 21401 or by email to zcancelme@nctours.com - and must include the registrant's name, complete address and account number. **Non-Participants in Refund Guarantee Program** - If your cancellation letter is postmarked more than 60 days prior to the group's departure, New Century Tours will retain the deposit amount; if your cancellation is postmarked 45-60 days prior to the group's departure, NCT will retain 50% of the total tour price; if your cancellation is postmarked 44 days or less prior to the group's departure, NCT will retain 100% of the tour price. **Enrollment in the Refund Guarantee Program** - You will receive a refund, minus the cost of this program (and any other non-refundable fees), if you cancel at any time prior to departure for any reason. Tour dates are sometimes changed, due to canceled flights, airline strikes, unavailable flights, etc. If your tour dates are changed by New Century Tours, and you find it necessary to cancel because of this date change, you will be allowed to receive a full refund if your letter of cancellation is postmarked no more than 14 days after the date change is announced. Your letter must state that the date change is your reason for canceling. Reservations are not transferable at any time. Money is refunded to the original payer. Refunds will be processed each week with a two week turnaround time. Fees for late payments, late registration, service and handling fees, returned checks and merchandise are not refundable. Exceptions to our refund policy are not made.

General Policy: We accept MasterCard and Visa. No personal/business checks will be accepted after the final payment deadline. If your balance is not paid in full by the final payment deadline, a \$35.00 late fee will be assessed to your account. Any checks returned by your bank, for any reason, will result in a \$40.00 service charge. New Century Tours reserves the right to make additions or deletions in the program when deemed advisable for the well being of the group or changes in circumstances. The right is further reserved to refuse or accept any person as a member of the group. New Century Tours does not accept responsibility for lost or stolen items. Any likeness (video or film) taken of a tour participant or any statement or comment made by a participant of a tour with New Century Tours may be used in materials published by New Century Tours without compensation. Due to the nature of group travel, deviated flights, extended stays and frequent flyer miles are not available to participants. If payment in full is not received by the final payment deadline, as stated in the registration letter, your tour space is not guaranteed. Students are placed four to a room. Unless otherwise noted on the registration form, adults will be registered and invoiced two to a room. **Additional charges apply for adults: 15% of student price for triple occupancy; 20% of student price for double occupancy; 30% of student price for single occupancy.**
